Mission Statement: Multi-Purpose Community Action Agency eliminates barriers to economic self-sufficiency for low income families and senior citizens through community supports and partnerships.

Who We Are: Multi-Purpose Community Action Agency (MPCAA) is one of 23 community action programs in the state of Kentucky. The agency serves the counties of Bullitt, Shelby and Spencer. Our agency also serves families in Jefferson with weatherization services.

MPCAA is part of a national movement created in 1964 with the passing of the Economic Opportunity Act. Community Action Agencies work on behalf of individuals and families to help them improve their daily living situations and to stabilize the family unit.

Community Action is about real people; the individuals who volunteer time and money; the individuals and families who find a road out of poverty into self-sufficiency; and the agencies themselves whose dedicated staff encourage and inspire.

Multi-Purpose Community Action Agency provides a variety of services to clients over 60 years of age, to low-income clients and to at-risk families. MPCAA is incorporated as a private nonprofit 501(c)(3) agency and is governed by a volunteer board of directors.

The agency has been providing services for more than 40 years and continuously strives to identify needs of the community and to develop services to meet those needs. Through our various program services we promote self-sufficiency and independent living, helping our clients to achieve their own success by focusing on the positive aspects of their lives.

PROMISE OF COMMUNITY ACTION:

Community Action changes people's lives, embodies the spirit of hope, improves communities, and makes America a better place to live. We care about the entire community, and we are dedicated to "Helping People Help Themselves" and each other.

2021 brought many challenges and taught us many lessons about overcoming barriers that no one could have predicted or planned. Throughout, we found a way to best serve our low income families that desperately needed assistance. We persevered and are very proud of our accomplishments and services we provided.

- Provided 25,493 meals for seniors, a variety of delivery options were utilized –some delivered to their homes, some drive up service and some at our Senior Centers when the reopened in Sept., 2021.
- Provided 23,390 units of support services activities to the elderly
- Provided support and meal services to 1,416 unduplicated senior citizens in our service areas
- Assisted 3,610 families with \$673,944 in utility assistance through LIHEAP Funds
- Weatherized homes for 15 low income families to help lower energy costs in Bullitt, Spencer & Shelby
- Weatherized 22 homes for low income families in Jefferson County to help lower energy costs
- Provided 2,111 boxes of food to senior citizens in Bullitt and Spencer Counties
- Provided 2,467 households with boxes of food and produce to help low income families suffering from food insufficiency (Spencer)
- Provided assistance to 73 families for Louisville Water Utility bills in the amount of \$19,745 (Bullitt County)
- Served 51 families with other Utility Assistance through Wintercare funds in the amount of \$12,695.
- Provided \$9,504 to 29 Families through CSBG CARES funding.
- Assisted 425 families with \$109,271 in water assistance through the LIHWAP funding (Water Assistance)
- Provided 68 families with \$5,280 in vouchers from Goodwill
- Provided \$6,987 to 22 Families in CDBG which is Covid 19 Utility Relief Assistance
